SECTION 4: First aid measures

4.1. Description of first aid measures

First-aid measures general : Never give anything by mouth to an unconscious person. If you feel unwell, seek medical advice (show the label where possible).

thoroughly washed with water. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

First-aid measures after ingestion : Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Rinse mouth. Give 100 - 200 ml of water to drink. Obtain immediate medical attention.

4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects after inhalation : May cause drowsiness or dizziness. Nausea.

Symptoms/effects after skin contact : Repeated exposure may cause skin dryness or cracking. Repeated and/or prolonged skin

contact may cause irritation.: Causes serious eye irritation.

Symptoms/effects after ingestion : Ingestion may cause discomfort. May cause stomach pain or vomiting if ingested.

4.3. Indication of any immediate medical attention and special treatment needed

Treat symptomatically.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Symptoms/effects after eye contact

Suitable extinguishing media : Alcohol-resistant foam. Carbon dioxide. Dry chemical. For large fire: Water spray.
