1. GETTING YOUR ADDITIONAL REBATE:

(a) If, between April 1 and June 30, 2009 you purchase a Qualifying Multifunction display in accordance with the terms and conditions of Raymarine's Upgrade and Trade Sales Event Rebate (the "Upgrade and Trade Sales Event") and provide your authorized Raymarine dealer with any brand of marine electronics screen (may include any radar, chartplotter, fishfinder or multifunction display), you will be eligible to receive an additional \$50 rebate in addition to your Upgrade and Trade Sales Event rebate (an "Additional Rebate"). The Upgrade and Trade Sales Event runs between April 1, 2009 and June 30, 2009. Terms, conditions, Claim forms and a list of "Qualifying Multifunction Displays" are available from your authorized Raymarine retailer or dealer, or online at www.raymarine.com. **ADDITIONAL REBATES ARE NOT AVAILABLE OR OFFERED WITHOUT A CORRESPONDING PURCHASE OF A QUALIFYING MULTIFUNCTION DISPLAY AT THE SAME TIME AS THE TRADE-IN.**

THE TRADE-IN PERIOD BEGINS ON APRIL 1 AND ENDS ON JUNE 30, 2009. TRADE-INS MADE AFTER JUNE 30, 2009 WILL **NOT** BE ELIGIBLE FOR AN ADDITIONAL REBATE.

(b) You must complete the front of this form and sign it in the space provided. In addition, a representative or salesperson of the authorized Raymarine dealer or retailer that accepts your Trade-In must also sign and date this form in space provided. Your signature indicates your agreement to comply with and be bound by these terms and conditions.

(c) Mail the completed form together with your fully completed Upgrade and Trade Sales Event Claim form. **THIS FORM MUST BE MAILED TOGETHER WITH YOUR UPGRADE AND TRADE SALES EVENT CLAIM FORM IN ORDER FOR YOU TO BE ELIGIBLE TO RECEIVE THIS ADDITIONAL REBATE. ONLY ONE ADDITIONAL REBATE PER CUSTOMER.**

2. GENERAL TERMS AND CONDITIONS:

Additional Rebate available only to retail customers who are residents of the U.S. and Canada (but void where prohibited or restricted by law) and may not be combined with any other offer from Raymarine. In the event that you do not qualify for a rebate pursuant with the terms and conditions of the Upgrade and Trade Sales Event, you will not be eligible for an Additional Rebate.
